I hereby certify that the information and statements contained herein are true and correct. Check must accompany form and be received by due date to avoid any penalty or interest. The return must be filed on or before the due date shown above.

Who Must File:

Each employer within the City of Ironton, Ohio, who employs one ore more persons is required to withhold the tax of one percent (1%) from all compensation paid taxable employees at the time such compensation is paid, and to file W-1 form and remit tax to the City Income Tax Department on or before the last day of the month next following the quarterly period in which the withholding deduction was made.

Who Must Pay:

All persons eighteen (18) years of age or older must pay City Income Tax, as it may apply.

Failure to File Return and Pay Tax:

Any taxpayer who shall fail or refuse to make any return or declaration required by the Ordinance, or any taxpayer who shall refuse to pay the tax imposed by the Ordinance, or any taxpayer who shall refuse to permit the administrator to examine his books, or who shall knowingly make any incomplete, false or fraudulent return, or who shall attempt to avoid the payment of tax, shall be guilty of a misdemeanor and shall be fined not more than \$500 or imprisoned for not more than sixty (60) days, or both. The failure of any taxpayer to receive a return or declaration form shall not excuse him from making a return or declaration or from paying the tax.

How to Prepare this form:

Line 1 – Enter total compensation PAID all taxable employees during the month for which return is made. If no compensation was paid during the month, so indicate and return form. Line 2 – Enter total actual tax withheld from taxable employees during the month for City of Ironton, Ohio-Income Tax Line 3- To adjust current payment of actual tax withheld for underpayment or overpayment in previous month.
